ARTICLES OF INCOPPORATION

In compliance with the requirements for Non Profit Corporations of the State of New Mexico, the undersigned, does hereby certify:

ARTICLE ONE

The name of the corporation is Silver Townhouses Homeowner's Association, Inc., hereafter called the "Association." ARTICLE TWO

The principal office of the Association is located at 3636 Menaul NE, Suite 300, c/o Dee Ann Rogers, Albuquerque, New Mexico. Dee Rogers, whose address is 3636 Menaul, NE, Suite 300, Albuquerque, New Mexico, is hereby appointed the initial registered agent of this Association, and the registered office is at 3535 Menaul, NE, Suite 300, Albuquerque, New Mexico.

ARTICLE THREE

This Association does not contemplate pecuniary gain or profit to the members thereof, and the specific purposes for which it is formed are:

(a) to provide for maintenance, preservation and architectural control of the Common Area within that certain tract of property described as: Lot lettered "C" in Block numbered Four (4) of MANKATO PLACE, an Addition to the City of Albuquerque, New

Mexico, as the same is shown and designated on the replat of Lots 12, 13 and the East 1/2 of Lot 14 in Block 4 of said Audition as shown, in the records of Bernalillo County, New Mexico, and to promote the health, safety and welfare of the residents within the above-described property and any additions thereto as may hereafter be brought within the jurisdiction of this Association;

- perform all of the duties and obligations of the Association as set forth in that certain Condominium Declaration for Silver Townhouses, a Condominium, hereinafter called the "Declaration", applicable to the property and recorded or to be recorded in the office of the County Clerk of Bernalillo County, and as the same may be amended from time to time as therein provided, said Declaration being incorporated herein as if set forth at length;
- (c) to have and to exercise any and all powers, rights and privileges which a corporation organized under the Non-Profit Corporation Law of the State of New Mexico by law may now or hereafter have or exercise.
- (d) to have and to exercise any and all powers, rights and privileges granted to the Association of Unit Owners under the Condominium Act of the State of New Mexico.

ARTICLE FOUR

All assets remaining after the requirements of the Non Profit Corporation Act have been met shall be distributed to such persons, non profit societies, non profit organizations or non profit domestic or foreign corporations as shall be agreed upon by a vote of two-thirds of the members entitled to vote, or if there are no members, upon the vote of a majority of the directors, as set out in N.M.S.A. Sect. 53-8-49.

ARTICLE FIVE

Every person or entity who is a record owner of a fee interest in any Unit in the Silver Townhouses, a Condominium, including contract purchasers, but not contract sellers, shall be a member of the Association. The foregoing is not intended to include persons or entities who hold an interest merely as security for the performance of an obligation. Membership shall be appurtenant to and may not be separated from ownership of any Unit in the Condominium.

ARTICLE SIX

The affairs of the Association shall be managed by the Board of three (3) Directors. The numbers of Directors may be changed by amendment of the Bylaws of the Association.
